Subscription & Payment

Standard Trade Supporter costs £33.00 plus VAT (£39.60 including VAT) per annum.

- You will receive a link to the electronic copies of our quarterly magazine HISTORIC.
- Entrance to the Club Expo conference (held annually)
- The right to attend general meetings

- Access to historic vehicle specific material such as copyright law; what was called GDPR but since we left the EU is now the Data Protection Act 2018 etc

Each subscription term commences on 1 June and expires on 31 May. If joining part way through a year a pro rata payment will be required for each full calendar month remaining.

Please note we are a voluntary organisation which exists to uphold the freedom to use historic vehicles on the road. We do this by representing the interests of owners of such vehicles to politicians, government bodies/officials, and legislators both in the UK and (through the Fédération Internationale des Véhicules Anciens, FIVA) in Europe.
