Dear Applicant,

Thank you for your interest in wishing to join the Federation of British Historic Vehicle Clubs. Please find below important details concerning your application.

## Subscription & Payment

The subscription is priced depending on the number of members you declare. For Clubs whose membership is over 64 members the cost is 47p per member. For Clubs with 63 members or less the subscription is priced at a flat rate of £30.00. please note we are a voluntary organisation which exists to uphold the freedom to use historic vehicles on the road. We do this by representing the interests of owners of such vehicles to politicians, government bodies/officials, and legislators both in the UK and (through the Federation Internationale des Vehicules Anciens or FIVA) in Europe.

Our preferred method of payment is via Internet Banking/BACS.

If choosing this method, please state your club name as a reference. Alternatively, we can accept credit/debit card payment over the telephone (01708 223111) or a cheque in the post.

For GDPR requirements we require the application form to be returned via post or scanned emailed document before your payment can be processed.

## Newsletter

The Federation will only provide one issue of FBHVC news for each edition (6 issues per year). A link to the electronic format of FBHVC News will sent to all contacts via email at no additional charge. If you wish to receive more printed issues, you have a choice; we can send additional copies to the same mailing address for an additional cost per annum as per below:

- Up to 2 copies to the same mailing address for an additional £2.82 per annum
- Between 3 to 5 copies to the same mailing address for an additional £5.04 per annum
- Between 6 to 8 copies to the same mailing address for an additional £14.58 per annum.

Alternatively, we can send an individual copy at a cost of £3.42 for each postal address listed.

Please indicate your requirements on the form. We regret we are unable to post outside of the UK.

We welcome Clubs to reproduce material within FBHVC News in your own publications. The only stipulation is the text must be unchanged and that credit is given to the Federation. Occasionally we may produce a copywritten item and these will be clearly identified.
