The subscription is priced at £72.00 for the year. Please note we are a voluntary organisation which exists to uphold the freedom to use historic vehicles on the road. We do this by representing the interests of owners of such vehicles to politicians, government bodies/officials, and legislators both in the UK and (through the Federation Internationale des Vehicules Anciens or FIVA) in Europe.

For GDPR requirements we require the application form to be returned via post or scanned emailed document before your payment can be processed.
